**General Description:** This is a professional position. The incumbent is responsible for managing complex technical tasks related to information technology in the designated department.

**Organization:** The IT Programmer Analyst-Senior is part of Hanover County's Career Development Plan (CD). The IT Programmer Analyst-Senior represents the first two (2) levels on the CD Ladder. The IT Programmer Analyst has four (4) levels ranging from IT Programmer Analyst to IT Programmer Analyst-Senior to IT Systems Engineer to IT Systems Engineer-Senior. The IT Programmer Analyst-Senior reports to the Director or Deputy Director, dependent upon project team assignment, and may supervise support staff. Specific assignments are supervised by an I.T. Project Manager.

### **Essential Functions:**

- Performs various high-level tasks dependent upon area of assignment and technical environment.
- Installation and support of hardware (i.e. computers, network/telecommunications equipment, etc).
- Development and/or installation and support of software systems (i.e. operating, application, utility systems).
- Performs related work as assigned.

**Knowledge, Skills and Abilities:** General knowledge of Information Technology hardware and/or software. Detailed knowledge of specific areas of hardware and/or software dependent upon area of assignment. Excellent troubleshooting and problem-solving skills. Excellent oral and written communications skills and ability to prepare accurate and detailed documentation. Ability to use independent judgment, manage and prioritize multiple tasks and assignments, and work independently. Ability to work with users and hardware/software vendors.

**Education, Experience and Training:** Four (4) years' college education, required. Bachelor's degree in systems engineering, computer science, information systems, or related field, preferred. At least two (2) years of Information Technology experience, with specific areas of expertise, dependent upon area of assignment, desired. Specific experience and training may be added as needed per specific area of assignment (i.e. server, network, telecommunications, application, etc. support). Any equivalent combination of relevant education, experience, and training totaling at least six (6) years is required, with the approval of the Director or Deputy Director, is acceptable.
